## **Statewide Meeting on Early Childhood Education Planned**

The Louisiana Association of United Ways (LAUW) and Education's Next Horizon will jointly host a statewide meeting on early childhood education on February 2, 2012 from 9:00 a.m. to 11:00 a.m. at the LAUW office, located at 2515 Canal Street in New Orleans. Organizations from every region of the state will convene to discuss the Governor's recently announced early childhood education reform proposals. The groups will also discuss business engagement in early childhood education and funding for Birth-to-Five, Pre-K and Literacy. ## **Early Learning Business Collaborative Planned**

Education's Next Horizon and the Committee of 100 for Economic Development (C100) are planning a partnership initiative to increase business awareness of the benefits of early childhood education and to strengthen the early learning system. The Committee of 100 is a private non-profit organization whose membership includes the top CEOs of leading private and public companies in Louisiana and University Presidents of Louisiana's institutions of higher learning. The Committee's primary focus is to help Louisiana to attract and retain industry.

Working in partnership with other stakeholders across the state, the business partnership will focus on improving the quality of early learning programs as well as expanding access to needy families. The state's School Readiness Tax Credit offers an ideal vehicle for accomplishing these goals.

While the School Readiness Tax Credit has existed since 2007, the "business" component of the tax credit has great potential for expanded use. Under state law, businesses can receive tax credits by investing directly in high-quality rated child care centers. Businesses can also receive a 100% refundable tax credit up to \$5,000 by donating to designated Child Care Resource and Referral Agencies that support child care service providers.

Governor Jindal and the Board of Elementary and Secondary Education have made kindergarten readiness one of the building blocks for recently proposed education reforms. Business support of early learning will be a necessary ingredient for the success of those initiatives.
